WHEREAS, one such condition that allows fireworks to be discharged is in Section 205.2210.B.5. which states, "In an approved fireworks display.", and

WHEREAS, without further description in the code, only the Board of Aldermen may grant such approval, and

WHEREAS, the applicant seeks to discharge consumer fireworks (Class C/1.5G) purchased from local tents on July 19, 2025 as part of a sixteenth birthday celebration at 9:00 p.m. lasting approximately twenty minutes.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF SMITHVILLE, MISSOURI, AS FOLLOWS:

THAT LARRY FULLER IS HEREBY APPROVED TO DISCHARGE FIREWORKS ON JULY 19, 2025 FOR APPROXIMATELY TWENTY MINUTES AND TO BE COMPLETED BY 9:20 P.M.
