**4. City Administrator's Report**

Cynthia Wagner noted that her report stands as presented. She noted that the Commercial Avenue project was originally expected to begin yesterday, however, mobilization began today. Some access to the school was temporarily blocked, which caused minor issues. An on-site meeting was held with the contractor today to address the situation. They have committed to maintaining school access throughout construction. Coordination with the school district is ongoing and construction is scheduled to begin tomorrow.

Cynthia highlighted the upcoming holiday schedule. City offices will be closed in observance of Veterans Day next Tuesday and noted that she will be out of the office Thursday, Friday, and Monday. Gina Pate, Assistant City Administrator, will be available on Thursday and Friday. Cynthia added that she would be available by phone over the weekend if necessary.

Cynthia noted that the Planning and Zoning Commission meeting originally scheduled for next Tuesday, November 11, has been moved to Thursday, November 13, due to the Veteran Day holiday. As a result, the agenda packet for the next Board of Aldermen meeting will be posted late Friday afternoon to include the Planning items.

Mayor Boley has declared two additional holidays, Friday, December 26, and Friday, January 2. City Hall will therefore be closed December 25 and 26 and January 1 and 2 to allow staff additional time off. Cynthia noted that given this schedule and the lack of pending agenda items, the January 6 Board of Aldermen meeting has been cancelled.

### **5. Bill No. 3085-25, Annexation Lots 1 & 4, Phase I Whispering Creek Farms – 2<sup>nd</sup> Reading**

Alderman Atkins moved to approve Bill No. 3087-25, amending Sections of Chapter 400 of the zoning code authorizing new overlay district regulations. 1<sup>st</sup> reading by title only. Alderman Hartman seconded the motion.
