## Resolution 1527, Agreement with Clay County Senior Services

## 4. Committee Reports

Alderman Wilson reported on the November 13 Planning and Zoning Commission meeting. She reported that significant construction activity is underway. The contractor has begun paving the streets in Clay Creek Meadows, and they also discussed the Umholt Homestead rezoning and final plat included on this agenda.

## 5. City Administrator's Report

Cynthia Wagner noted an update on personnel, currently there are eight vacancies that we are in recruitment for and the addition of three new positions.

Cynthia addressed a few questions that came up regarding the Citizen Satisfaction Survey and provided an update. The survey was mailed to 2,250 addresses. ETC Institute purchased an address list and sent the survey to all households identified as being within the city limits. The survey is address-based to ensure only one response per household and to prevent anyone from submitting multiple responses to influence the results. She noted that respondents must provide their address at the end of the survey, which allows ETC to verify responses and geotag the data. This will help us track feedback from all areas of the community.

Cynthia explained that after forwarding these questions to Robert Haycock at ETC Institute earlier today, he provided an update to she and Gina. She noted that we cannot predict exactly when surveys will arrive in mailboxes due to postal timing, 69 responses have already received, submitted either electronically or by mail. ETC's goal is to collect 300 responses to meet the required statistical significance. With the receipt of the 69 responses we are already about a quarter of the way there.

Cynthia also noted that City Hall will be closed next Thursday and Friday in observance of Thanksgiving. She wished everyone a very Happy Thanksgiving.

Lastly, this afternoon Cynthia and Chuck met with Damon Hodges, the relatively new Clay County Administrator. Cynthia explained that Mr. Hodges has been meeting with city managers throughout the county to learn more about the issues facing each community. They had a very productive conversation about our shared road agreement and the waterline serving Clay County Parks and Recreation under Smithville Lake. She noted that it was a very good discussion overall.
