SMITHVILLE BOARD OF ALDERMEN WORK SESSION

September 23, 2025 6:30 p.m. City Hall Council Chambers and Via Videoconference

1. Call to Order

Mayor Boley called the meeting to order at 6:32 p.m. A quorum of the Board was present: Melissa Wilson, Marv Atkins, Kelly Kobylski, Dan Hartman, Leeah Stone and Ronald Russell.

Staff present: Cynthia Wagner, Gina Pate, Chief Lockridge, Chuck Soules, Rick Welch, Matt Denton, Linda Drummond and Captain Roetman.

2. FY2026 Budget Discussion

Finance Director Rick Welch noted that the recommended budget last discussed adds \$450,351 in expenses resulting in an ending fund balance of \$2,876,697.

With the receipt of the official notice of a State audit and the cost to the City is stated between \$125,000 - \$150,000. Because the estimated audit cost is significant, staff requests additional Board review of funded items and fund balance input to present the FY2026 recommended budget on October 7, 2025. Rick noted that the cost of the audit could be a cost share between the General Fund and the Utilities Fund 70/30 and that would be a cost of \$105,000 from the General Fund. Rick asked the Board if they wish to keep the highlighted items in the budget or if they want to cut some items to cover the \$105,000 cost of the audit.
