AGENDA ITEM: Resolution 1538, approving Change Order No. 1 for Bid No. 26-01, Smith Fork's Sanitary Force Main Improvement and Little Platte River Water Crossing

REQUESTED BOARD ACTION

A motion to approve Resolution 1538, approving Change Order No. 1 for Bid No. 26-01, Smith Fork's Sanitary Force Main Improvement and Little Platte River Water Crossing in the amount of \$248,794.96.

SUMMARY

Clay County owns the watermain that runs along Highway DD and goes under the lake to the County campgrounds. The water line has had several leaks, some under the lake. The county has laid a new line to their campground and has shut the waterline off under the lake. The part of the watermain that remains in service provides service to Smith Fork's Campground, Smithville Park Dept, Litton Center and a residence. The County has been billed several thousand dollars for water lost in these breaks and they desire to release the line to the City.

Menke Excavation has been awarded the bid for RFP 26-01, River Crossing and Smith Fork's force main. Menke has provided the attached Change Order No. 1 to complete a new water line along HWY DD to replace the County main and the City will then take over service to this area. The Change Order No. 1 is in the amount of \$248,794.96.

Staff is recommending adding this Change Order No. 1 to the River Crossing and Smith Fork force main for the following reasons:

- Menke Excavation was the most responsive bidder on the River Crossing and SF force main project
- Menke Excavation has completed several similar projects for the City of Smithville and done a good job
- With the upcoming camping season, it would be good to have this line replaced to ensure service to the campground. Last year we had to shut the line down when there was a leak that was draining the North tower.
- The new main will be installed with the intent to extend into the Park to provide water to the campground and future development of the park.

The 2026 Combined Water and Wastewater Systems Fund has \$170,000 budgeted for this project and the RFP 26-01 has come in under budget by \$253,000, therefore sufficient funding is available.

RESOLUTION 1538

A RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR BID NO. 26-01, SMITH FORK'S SANITARY FORCE MAIN IMPROVEMENT AND LITTLE PLATTE RIVER WATER CROSSING IN THE AMOUNT OF \$248,794.96

WHEREAS, Clay County owns and operates the watermain along DD Highway that goes under Smithville Lake to serve Clay County campground and also provides water service to Smith Fork's Campground, Park Department, Litton Center and a residence; and

WHEREAS, the water main has failed several times, needs to be replaced and Clay County desires to abandon this line and give it to the City of Smithville; and

WHEREAS, Menke Excavation was awarded the bid for RFP 26-01 and has provided a quote to add the replacement of the HWY DD water main in the amount of \$248,794.96.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF SMITHVILLE, MISSOURI:

THAT Change Order No. 1 for Bid No. 26-01, attached hereto and incorporated into this resolution as if fully set forth herein, for the replacement of the watermain on HWY DD is hereby approved in the amount of \$248,794.96.

FURTHER, THAT the appropriate officials of the City are hereby authorized to negotiate and entered into any agreement, contract, or other instruments necessary to carry out the intent of this resolution and to execute the same on behalf of the City provided that said agreement, contract, or other instrument substantially complies with the pricing, terms, and other obligations contained in Change Order No.1 for Bid No. 26-01
