1. Call to Order

Hailey called the meeting to order at 6:00 PM. Parks and Recreation Committee members present were Jeremiah Bloemker, Hailey Kellerstrass, Shaunna Houghton, Mayor Boley, Alderman Shipley, Kyle Squires, and Ben McClanahan. Staff present were Matt Denton and Alex Threlkeld.

2. Approval of Minutes from April 24, 2025, Parks and Recreation Committee Meeting

The mayor made a motion to approve the minutes. Hailey seconded. Voice vote, all ayes

3. Staff Report

Diamond Crest Parking Lot and Trail Update:

During the construction of the Splash Pad Parking Lot, contractors encountered unexpected soil and compaction issues that required additional excavation. As a result, the splash pad water line, restroom electrical, and drainage system had to be lowered by about a foot. A new vault pit was also installed to allow for future maintenance, and existing electrical lines for the splash pad were rerouted. Once that work was completed, the Public Works Department set the gravel base in-house to help reduce costs before Hoy Excavation returned to place the second layer ahead of asphalt paving.

Public Works finished their portion of the work, after which Hoy Excavation allowed the site to dry and settle. When they returned, testing showed the area was still not meeting compaction requirements, and they did not feel confident moving forward with the asphalt.

Public Works and I have been working closely with Hoy Excavation to evaluate the full scope of the issue. We have worked out a solution and hope to complete the project before winter weather sets in.

The splash pad will be closed on Tuesday after Labor Day weekend to allow the area to dry up and allow crews to work.

Haunted Campground

Reservations for the Smithville Haunted Campground opened on August 1 and sold out in less than eight minutes. The event is scheduled for October 18, 2025. The Committee is currently finalizing vendor registrations and securing event sponsors.

Staffing Changes

On August 15, Mark Fairchild completed his last day with the Parks Maintenance Division after more than 2.5 years of dedicated service. Mark was an outstanding employee, and

he will be greatly missed. The park maintenance worker position will be posted on October 18, 2025.

In the FY26 budget, the Board of Aldermen is working to approve a Parks and Facilities Manager that will be supervised by the Parks and Recreation Director, and the position will oversee the Park Maintenance Division.

Community Awards Banquet

The Smithville Community Awards Banquet is scheduled for February 26, 2026. Once again, the Parks and Recreation Legacy Fund, in collaboration with the City of Smithville, is partnering with the Smithville Area Chamber of Commerce to host "A Night of Enchanted Honors" at the White Iron Ridge. This gala dinner honors exceptional citizens and dedicated volunteers within our community while raising crucial funds for the Parks and Recreation Legacy Fund and the Smithville Chamber of Commerce.

Senior Center:

The Smithville Senior Center has been having a great summer. Amy has been putting together great events and programs to keep the seniors busy. The fitness classes on Monday-Friday mornings are being well-received, and more and more are starting to attend Tuesdays and Thursdays. Please see the numbers Amy reported for Q2 (April-June):

The senior center was open for 62 service days in the reporting period. 1,130 meals were served in the reporting period, up from 680 in Q1. We welcomed a total of 69 new clients in Q2, more than doubling from 28 in Q1.

Community Awards Banquet

The Smithville Community Awards Banquet is scheduled for February 26, 2026. Once again, the Parks and Recreation Legacy Fund, in collaboration with the City of Smithville, is partnering with the Smithville Area Chamber of Commerce to host *"A Night of Enchanted Honors"* at White Iron Ridge. This gala dinner celebrates outstanding citizens and dedicated volunteers in our community while raising vital funds for both the Parks and Recreation Legacy Fund and the Smithville Chamber of Commerce.

Matt mentioned that following last year's event, the Banquet Committee and staff agreed it was important for the Parks and Recreation Committee to play a more active role, as the banquet directly supports a major Parks and Recreation project. After discussion, it was decided that the Committee will assist with the Silent Auction. Hailey, who has supported this portion of the event for the past three years, will be working with you the day before and on the day of the event to ensure everything runs smoothly.

Matt mentioned that attendance at this event is highly encouraged. If you are unable to attend, please let him know as soon as possible.

Senior Center Building Name

The Smithville Senior Center has been located west of City Hall since its opening in 2013. Until 2019, the facility was used exclusively for senior services. That year, the Board of Aldermen directed the Parks and Recreation Department to begin managing community rentals of the space when not in use by seniors. In 2023, our department entered into a new agreement with the Senior Board outlining how we would continue offering senior services while also providing greater support in daily operations, managing the senior services grant, and expanding community rental opportunities and programs. That winter, significant upgrades were made to the interior to create a more welcoming space for both seniors and community members.

In 2024, staff worked with Clay County Senior Services to add a part-time senior services position under the direction of the Parks and Recreation Director. Since then, the senior program has grown while our Recreation team has also expanded use of the facility for rentals, events, and programs.

Through conferences and discussions with other departments, we are seeing a generational shift in senior center attendance. Today, senior centers are more often utilized by older age groups, while those in their 60s and 70s may be hesitant to participate. Research shows there is a stigma around the word "Senior," and that removing it from building names and advertisements can help attract a broader audience.

With that in mind, staff is seeking direction on a potential name change to make the facility more inviting to both the 60+ community and the general public for events and programs.

Staff is recommending renaming the facility the **“Smithville Activity Center.”**

Matt mentioned that if you have additional name suggestions, please bring them to the committee for discussion. The committee agreed that they would like to hear from the Senior Center Board first and discuss at the next meeting

Smith’s Fork Park Engineering and Design

In 2020, the Parks and Stormwater Sales Tax was approved by voters, and in 2021 the Parks and Recreation Master Plan was adopted by the Board of Aldermen. This plan provides a ten-year roadmap for meeting community needs with the new funding source. One of the major projects identified in the plan is the restructuring of Smith’s Fork Park and the athletic fields.

Currently, three ballfields are located at Heritage Park and two at Smith’s Fork Park. The long-term vision is to develop Heritage Park into more of a community hub and extension of the downtown. To make that transition while still offering programs and rentals, the restructuring of the Smith’s Fork Park athletic fields must occur first. When the Master Plan was adopted in 2021, the estimated cost for this project was just under \$3 million. Through inflation and supply cost we are estimating this cost has increased significantly.

To help fund the project, staff planned to set aside \$300,000 annually from the newly approved sales tax. Following this plan, the fund should have close to \$2 million available by 2027 to launch the project.

In May 2025, staff recommended to the Board of Aldermen that engineering be moved up to 2026. Beginning the design phase earlier would allow for committee and community feedback while also providing updated cost estimates. The Board has since recommended that engineering be included in the 2026 Parks and Stormwater Sales Tax budget.

If the final budget is approved on October 21, staff will begin preparing a scope of work to either issue a Request for Qualifications (RFQ) or partner directly with a firm under a design-build approach. More discussion with the Board of Aldermen is to come on November 4.

Leading up to this October meeting, staff ask the Committee to review the [Master Plan](#) and research ballfield complexes to bring forward ideas and discussion points that will help staff in developing the project scope. Some ideas and discussions would be, Turf Fields, Parking, Shade, Seating and Lighting. Matt mentioned he would like to go around the room and note some of the ideas for discussion.

Diamond Crest Parking Lot and Trail Update:

The Diamond Crest parking lot construction has been completed! The asphalt work and striping have finished, and final grading was completed earlier this month.

The OK Railroad Trail project was bid in November. Epic Concrete Construction was awarded the contract. Construction is scheduled to start in the spring, with the goal of completing the project by Memorial Weekend.

Staffing Changes

To kick off the new year, we have welcomed a new Park Maintenance Worker, Jeremy Couch, to our team. A Smithville native, Jeremy has worked closely with our staff during his time at Pack's Hardware.

Additionally, on Monday, February 2, 2026, our new Recreation Coordinator, Cassidy Childerston, will be joining us. Cassidy has worked seasonally in our Recreation Department, and you may have seen her at many of our programs and events over the past year. She brings a wealth of experience in hosting programs and events for youth, and she is excited to start her role and introduce new ideas to the community.

Smith Fork Park Project Update:

At the November 18, 2025, Board of Aldermen work session, staff presented a discussion on alternative construction project delivery methods. The Board directed staff to further review these construction options and bring forward recommended methods for upcoming projects.

Over the past few years, the City has experienced several challenges in delivering large capital improvement and infrastructure improvement projects. These challenges include: Project schedule delays and equipment procurement issues, Low-bid contractors lacking capacity or resources to perform, and unforeseen site conditions resulting in significant change orders.

To improve predictability and performance, staff have reviewed alternative project delivery methods as potential options for larger, more complex projects.

On January 20, 2026, staff presented again to the Board of Aldermen on the direction staff thinks is best for the Smith's Fork Project.

Staff is recommending proceeding with the selection of an owner representative that will assist staff with the development of the project, estimates, contractor selection, and work through the various alternative delivery methods and RFQ processes.

Owners Representative (OR) acts as the City's advocate and technical resource from project planning through construction. The OR does not perform construction work, but instead provides independent expertise to assist staff in navigating project delivery options and evaluating the most appropriate path forward. This includes guidance related to cost estimating, scheduling, constructability, and risk management, as well as assisting with procurement processes and ensuring fiscal accountability. The OR would also support collaboration among the City, design professionals, and construction partners while helping protect the City's interests throughout the life of the project.

Staff will continue to provide updates on the project and will be looking for a Parks and Recreation Committee Representative to sit in on interviews for the Owners Representative.

Senior Center Building Name

Additionally, this building is included in our Parks and Recreation Master Plan, which is part of a larger strategic vision. The aim is to expand beyond the current facility by increasing senior services, recreational programs, and facility rentals. The road to a bigger facility is to show the need.

Staff would like to clarify that there is no plan or discussion about removing senior services from the building or our program offerings. Our goal is to continue increasing attendance and providing more opportunities for the community.

With all this in mind, staff is seeking direction on a potential name change to make the facility more inviting to both the 60+ community and the general public for events and programs.

Staff was scheduled to meet with the Smithville Senior Board on Friday, January 23, 2026, but the meeting was cancelled due to the weather. It is rescheduled for Wednesday, January 28, 2026. Staff will provide the report at the meeting.

Staff will be looking for a motion to move forward with a name change. If the committee has any suggestions, we will open it up for further discussion.

Park Naming Discussion for Current “Diamond Crest Park”:

The park currently known as Diamond Crest Park was originally named based on its proximity to the Diamond Crest neighborhood. Since that time, the park has evolved beyond a single-neighborhood facility and is now physically connected to three surrounding neighborhoods, functioning as a true community park rather than a neighborhood park.

With the recent completion of the new parking lot, the expected construction of the OK Railroad rail connection, and the existing splash pad, access to and use of the park will continue to grow. In light of these improvements and features, staff recommends starting a formal process to establish an official name for the park.

Staff proposes opening the naming process to the community through City social media and the City newsletter, inviting residents to submit name suggestions over a defined period. Staff will review all submissions and select the top three name options, which will be brought back to the Parks and Recreation Committee for consideration at the April meeting.

The goal is to finalize an official park name in advance of a planned ribbon-cutting ceremony around Memorial Day weekend, allowing the new name to be incorporated into signage and public communications.

Staff is looking for a motion to move forward with this process. If the committee has any suggestions, we will open it up for further discussion.

2025 Smithville Parks and Recreation Year-End Review

 - Lay the foundation for the staff capability and capacity to implement the infrastructure plan, raise the necessary funds, and launch new programming. **(Completed in 2022)**

- The medium-term period (4-6 years) aims to:
 - Continue the neighborhood parks, with an initial focus on Hawthorne Court Park **(Construction first. Added art Downtown in 2023)**
 - Add a sports court at Smith's Fork Park and begin the longer-term infrastructure planning in this area. The Sports Court could include tennis, basketball, and pickleball options. **(Added into SF 2027 Project)**
 - Support the implementation of trail components of the Transportation Plan. **(OK Trail, Riverwalk, and Grant submissions for Eagle Parkway)**
 - Amplify the fundraising with a focus on Heritage Park redevelopment. **(Community Awards Banquet)**
 - The Bold Step in this period is the major redevelopment of Heritage Park, including trail connectivity along the river, landscaping, and new community amenities. (TBD after SF Project)
 - Support and foster developer contributions to complete appropriate trail connections, add new neighborhood parks as developments occur, and encourage private investment in Riverwalk Park. **(2018-2025 Sidewalk Improvements)**
