City of Smithville 2025 Yard Waste Collection Guidelines

To provide the best possible yard waste collection service, please observe the following guidelines:

- Up to 10 bags and/or bundles per collection day. Maximum weight per item is 50 pounds. Yard waste must be set at the curb in either paper bags or bundles no larger than 18" x 36" and tied with twine. Our processor will not accept bags or bundles with tape, and taped items will be left at the curb.
- We only collect **residentially generated yard waste**, including grass, leaves, tree limbs less than 2 inches in diameter and small shrubs. Fencing, landscape timbers, flowerpots, yard decoration, mulch, rock, dirt and similar items are not considered yard waste and will not be collected.
- Collection begins at 7 a.m. Please make sure that your items are placed at the curb and accessible from the street prior to that time on your collection day.
- GFL hauls Smithville yard waste to a licensed composting facility that does not accept plastic bags, trash, construction materials, animal waste or food waste. Any bags that contain prohibited items will not be collected.
