AGENDA ITEM: Resolution 1076 - Authorizing Improvements on Sixth Street

REQUESTED BOARD ACTION:

A motion to approve Resolution 1076, authorizing Superior Bowen to complete improvements on Sixth Street in an amount not to exceed \$94,256.76.

SUMMARY:

Diamond Creek is a residential subdivision east of Sixth Street and Manzanola Lane. As part of the development agreement the development is required to mill and overlay Sixth Street between Manzanola Lane and Spelman Drive.

The approach from Spelman Drive onto Sixth Street and the storm sewer on Sixth Street needs to be repaired before the overlay is complete. Superior Bowen has completed the infrastructure for the Diamond Creek subdivision and is ready to complete the mill and overlay. They have successfully completed the City's street maintenance program. Superior Bowen has provided a cost to complete the improvements on Sixth Street in an amount of \$94,256.76.

Infrastructure Maintenance

FINANCIAL CONSIDERATIONS:

The City's Street Maintenance Program came in approximately \$50,000 under budget. Additional savings from the Parks and Recreation/Public Works facility final design will not be used this year providing sufficient funds for this expenditure.

RESOLUTION 1076

A RESOLUTION AUTHORIZING THE EXPENDITURE OF FUNDS FOR IMPROVEMENTS TO SIXTH STREET WITH SUPERIOR BOWEN IN AN AMOUNT NOT TO EXCEED \$94,256.76

WHEREAS, Diamond Creek Subdivision entered into a development agreement to mill and overlay Sixth Street; and

WHEREAS, Sixth Street between Spellman Drive and Manzanola Lane is in need of additional repairs prior to the mill and overlay; and

WHEREAS, Superior Bowen is the contractor completing the infrastructure (streets, water and sewer) for the Diamond Creek Subdivision immediately adjacent to Sixth Street; and

WHEREAS, Superior Bowen has provided an estimate for the additional work in an amount of \$94,256.76.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF SMITHVILLE, MISSOURI:

THAT the expenditure of \$94,256.76 improvement to Sixth Street with Superior Bowen is approved.
