1. Call to Order

3. Staff Report

Legacy Fund Recap

The Legacy Fund/City of Smithville partnered with the Smithville Area Chamber of Commerce to host the "Night at the Oscars" at White Iron Ridge. The dinner honored citizens and volunteers within the community, while raising funds for the Legacy Fund. Kozak's, Chops BBQ and Aroma Bistro provided a great dinner. 300+ tickets between sponsors, nominees, and individual ticket sold. The event brought in \$27,350 from some great sponsors and \$5,555 from the Silent Auction and Fundraiser Game. After about \$12,000 In Expenses the grand total is \$24,000. The Legacy Fun/ City of Smithville will be splitting 50/50 with the Chamber.

Riverwalk Update

As of March 3, 2023, The City of Smithville has been awarded \$900,000 from the Missouri transportation Alternatives Program (TAP) funds through MARC's Active Transportation Programming Committee. Since that time, the 2025-26 TAP funding recommendations were approved by the MARC Board of Directors and have been incorporated into the 2022-2026 Transportation Improvement Program. With this Committee's recommendation the City will be matching the grant to finishing funding the project. The Riverwalk continues to follow the Parks and Recreation Master Plan and the Transportation Master Plan.

Diamond Crest Park Update

On March 9, 2023, staff met with BluSky PM, management for Clay Creek Apartment, to get an update on the parking lot and shelter house project donation progress. Staff was presented the plan for the parking lot and approved the design. Staff is helping get a quote on the desired shelter and BluSky is in communication with the contractor to get the parking lot and shelter foundation on their calendar. Staff expressed that we would like at least parking lot to be completed by Memorial Weekend. That is when the Splash Pad will be scheduled to open. That is also the goal for BluSky as long as it works with the contractor's schedule.

4. Community Garden

Mayor made a motion to postpone the discussion of the Community Garden. Alderman Hartman seconded. All Ayes.

5. Playground Surfacing at Heritage and Smith's Fork Playground

Matt explained that it is the policy by the City of Smithville, as contained in its Comprehensive Plan, that all newly platted or replated subdivisions in residential zoning districts shall provide for the placement of recreational open spaces, walking trails, and other park areas based upon the impact the intended residents will have upon the City Park infrastructure. Such open space shall be for either public recreational use or for the future use of the residents of that subdivision to ensure the proper balance of land use, design of urban areas and avoidance of the overcrowding of the land, or by payment of a fee in lieu of dedication to be used to improve other adjacent dedication parks. Those fees go into a Parks Improvement Revenue Fund managed by the City. Currently in the fund is \$83,000. Also, since the community passed the Parks and Stormwater Sales Tax, the fund is exceeding projected revue. With Parks Improvement Revue and savings in the Parks and Stormwater Sales Tax Fund, staff is looking at resurfacing Heritage Park Playground and caping Smith's Fork Park Playground surface. Cost varies depending on the desired surface. Staff is looking for the Committee to discuss if this is something you would like staff to pursue and make a recommendation to the Board to amend the FY23 budget or add to the FY24 budget. The committee would need to choose desired surface and vote to make a recommendation. If approved by the BOA, this would go out for low bid. Matt explained that Smith's Fork Playground was patched in 2018 and those patches have been removed by use.

Heritage Park:

Bonded Rubber: \$120,000-\$134,400 (Received two quotes. One was from early 2022) – Can be repaired in-house.

Turf and Pour in Place: \$141,024 (was told they are going to be close to same price

Smith's Fork Park:

Bonded Rubber: \$30,000-\$50,000 (Received two quotes. One was from early 2022)



Mayor explained that bonded rubber would be better for the playgrounds as they sit in flood plains. Dani said that the bonded rubber being repairable in house is a huge plus. Kyle asked what life expectancy is. Dani asked who else had it. Matt explained he toured a few parks, and it is holding up well. Matt mentioned the life expectancy is 10-15 years.

Mayor made a motion for Heritage Park and Smith's Fork Park Playground to be resurfaced with Bonded Rubber and be funded by the Parks Improvement Revenue Fund and Parks and Stormwater Sales Tax in FY23. Dani Seconded the motion. All Ayes.

Park Signage:

On July 21, 2022 staff updated the Parks and Recreation Committee, that as part of the first two years of the Parks and Recreation Master Plan, funds were budgeted for parks signs. At that moment only two parks had signs recognizing them as City Parks. The Committee chose to have a "Boulder" theme, similar to the Courtyard Park sign. The Committee also decided to start with only Wilder Flower, Helvey and Smith's Fork Park as the other four remaining are waiting for future construction to be completed. Last week, the three signs were installed! The signs were installed to allow for some landscaping to be completed around each one. This will be done this summer by staff.



Shared Facilities w/ Smithville United Church:

Smithville United Church leaders are currently drafting a MOU to share indoor and outdoor space for recreation programming. We are looking to start an open gym for Pickleball for the community. The are community members interested in volunteering to help run and coordinate.

Earth Day:

On April 23, 2023 We had a girl scout group plant 8 more fruit trees at Smith's Fork Park along Main Street Trail. Also, Heritage Tractor planted a tree at Helvey Park to celebrate the 25th anniversary and to honor the communities they serve.



Senior Center Program:

Over the past 6 weeks the seniors have been participating in a Matter of Balance class offered by Clay County Senior Services and MU Extension. This program is an evidence-based program that will help older adults reduce the fear of falling by setting goals to increase activity levels, encourage small changes to reduce fall risks at home, and teach ways to exercise to increase strength and balance. Part of the program is to inspect their homes and the Senior Center for fall hazards. In that inspection the seniors asked if we could add parking blocks to the parking lot so cars cannot block the sidewalk. Staff has parking blocks installed 1-week later.



Easter:

Smithville Parks and Recreation and the Smithville Chamber of Commerce partnered together to host an Easter Egg Hunt of May 8 at Heritage Park. There were over 10,000 eggs that were found in less than 3 minutes! The Chamber is ready for it to be even larger next year.

Community Art:

Worlds Her Canvas was delivered the morning of May 5!





Bike Race/ Wine Walk:

Humphrey's Gravel Adventure and the Smithville Main Street District happened downtown Smithville on May 6. We had 240 Registered riders that took on the challenging course.



2022-2023 Key Accomplishments


- Continue to pursue short-term goals from the Parks and Recreation Master Plan:

 - Emerald Ridge Neighborhood Park
- Expanded Senior Center Fitness classes, increased facility rental revenue from 2021, and painted the inside of the facility.
- Grew participation in current Parks and Recreation programs and added more recreational programs outside of sports (Art in the Park, Learn to Kayak)
- Held first fundraising event with the Smithville Chamber of Commerce to raise funds for Smithville Legacy Fund.
- Incurred no restroom related "report a concern" issues.
- Worked with multiple eagle scouts on projects within the scout area and painted restroom at Smith's Fork.
- Hired new Recreation Coordinator position (new position funded in FY2023 Budget).

PARK & STORMWATER SALES TAX FUND

Funding Overview

- The Park and Stormwater Sales Tax is a 0.5% (half-cent) special sales tax that was approved by voters on June 2nd, 2020.
- The City began to see initial collections of the sales tax in November 2020.
- The Park and Stormwater Sales Tax was authorized by voters to be in enacted until December 31st, 2040 (20 years).
- The sales tax is to be used for the purpose of operating, maintaining, funding, and/or financing parks and recreation needs and stormwater control.

2022-2023

Key Projects In Progress and Completed

Parks & Recreation

- · Completed Diamond Crest Park Playground, Sidewalk, and Fencing Improvements.
- Completed RTP grant application for the "OK" Railroad Trail (Phase I) to connect Diamond Crest to Lake Meadows.
- Completed LWCF (Land Water Conservation Fund) grant application for Emerald Ridge Park.
- Awarded \$900,000 in MARC funding for the Riverwalk Park & Trail.
- Installed Park Boulder Signs around the City Parks

Stormwater

- Completed a "Stormwater Needs Assessment" and cleared blockage in Owens Branch stream.
- Developed an "Illicit Discharge and Elimination Plan" as identified by the MS4 audit.
- Initiating stormwater projects on Quincy Boulevard, Bridge Street, and 4th Street & 4th Terrace during Spring/Summer 2023.
