1. Call to Order

Dani called the meeting to order at 6:00pm. Parks and Recreation Committee Members present were Dani Wilson, Jeremiah Bloemker, Kyle Squires, Hailey Kellerstrass, Mayor Boley and Alderman Hartman. Staff present were Matt Denton and Alex Threlkeld

2. Approval of Minutes from the January 26, 2023, Parks and Recreation Committee Meeting

Dani made a motion to approve minutes from the January 26, 2022, Parks and Recreation Meeting. Dan seconded. Voice Vote, all ayes

3. Staff Report: Legacy Fund Recap

The Legacy Fund/City of Smithville partnered with the Smithville Area Chamber of Commerce to host the "Night at the Oscars" at White Iron Ridge. The dinner honored citizens and volunteers within the community, while raising funds for the Legacy Fund. Kozak's, Chops BBQ and Aroma Bistro provided a great dinner. 300+ tickets between sponsors, nominees, and individual ticket sold. The event brought in \$27,350 from some great sponsors and \$5,555 from the Silent Auction and Fundraiser Game. After about \$12,000 In Expenses the grand total is \$24,000. The Legacy Fun/ City of Smithville will be splitting 50/50 with the Chamber.

Riverwalk Update

As of March 3, 2023, The City of Smithville has been awarded \$900,000 from the Missouri transportation Alternatives Program (TAP) funds through MARC's Active Transportation Programming Committee. Since that time, the 2025-26 TAP funding recommendations were approved by the MARC Board of Directors and have been incorporated into the 2022-2026 Transportation Improvement Program. With this Committee's recommendation the City will be matching the grant to finishing funding the project. The Riverwalk continues to follow the Parks and Recreation Master Plan and the Transportation Master Plan.

Diamond Crest Park Update

On March 9, 2023, staff met with BluSky PM, management for Clay Creek Apartment, to get an update on the parking lot and shelter house project donation progress. Staff was presented the plan for the parking lot and approved the design. Staff is helping get a quote on the desired shelter and BluSky is in communication with the contractor to get the parking lot and shelter foundation on their calendar. Staff expressed that we would

like at least parking lot to be completed by Memorial Weekend. That is when the Splash Pad will be scheduled to open. That is also the goal for BluSky as long as it works with the contractor's schedule.

4. Community Garden

Mayor made a motion to postpone the discussion of the Community Garden. Alderman Hartman seconded. All Ayes.

5. Playground Surfacing at Heritage and Smith's Fork Playground

Matt explained that it is the policy by the City of Smithville, as contained in its Comprehensive Plan, that all newly platted or re-platted subdivisions in residential zoning districts shall provide for the placement of recreational open spaces, walking trails, and other park areas based upon the impact the intended residents will have upon the City Park infrastructure. Such open space shall be for either public recreational use or for the future use of the residents of that subdivision to ensure the proper balance of land use, design of urban areas and avoidance of the overcrowding of the land, or by payment of a fee in lieu of dedication to be used to improve other adjacent dedication parks. Those fees go into a Parks Improvement Revenue Fund managed by the City. Currently in the fund is \$83,000. Also, since the community passed the Parks and Stormwater Sales Tax, the fund is exceeding projected revue. With Parks Improvement Revue and savings in the Parks and Stormwater Sales Tax Fund, staff is looking at resurfacing Heritage Park Playground and caping Smith's Fork Park Playground surface. Cost varies depending on the desired surface. Staff is looking for the Committee to discuss if this is something you would like staff to pursue and make a recommendation to the Board to amend the FY23 budget or add to the FY24 budget. The committee would need to choose desired surface and vote to make a recommendation. If approved by the BOA, this would go out for low bid. Matt explained that Smith's Fork Playground was patched in 2018 and those patches have been removed by use.

Heritage Park:

Bonded Rubber: \$120,000-\$134,400 (Received two quotes. One was from early 2022) – Can be repaired in-house.

Turf and Pour in Place: \$141,024 (was told they are going to be close to same price

Smith's Fork Park:

Bonded Rubber: \$30,000-\$50,000 (Received two quotes. One was from early 2022)



Mayor explained that bonded rubber would be better for the playgrounds as they sit in flood plains. Dani said that the bonded rubber being repairable in house is a huge plus. Kyle asked what life expectancy is. Dani asked who else had it. Matt explained he toured a few parks, and it is holding up well. Matt mentioned the life expectancy is 10-15 years.

Mayor made a motion for Heritage Park and Smith's Fork Park Playground to be resurfaced with Bonded Rubber and be funded by the Parks Improvement Revenue Fund and Parks and Stormwater Sales Tax in FY23. Dani Seconded the motion. All Ayes.

Shelter House Improvements:

Park maintenance staff have been working hard to complete the SF Shelter house improvements this month. As of today, they have completed the East shelter and they will begin on the West shelter here shortly.



Haunted Campground:

On August 1st, 2023, Haunted Campground reservations were open to the public. In 2022, reservations were sold out in 8 minutes. This year, reservations were completely sold out in 7 minutes! Four sites were set aside for an auction to help provide another option for our amazing visitors; we wanted to create another opportunity for campers while raising funds for some great causes. The organizations are Larson's Cause and the Smithville Legacy Fund. The first round two sites raised \$280.00 and round two raised another \$280.00!

A few new changes will be happening this year. All vendors will be moved to the practice football field area, and we will be lining food trucks along the road outside the campground. We will also be upgrading the lighting for the event for safety.

Pickleball:

On July 24th, Smithville Parks and Recreation and the Smithville United Methodist Church partnered to offer indoor pickleball open play. The program was originally scheduled every M-W-F from 9:00 AM – 12:00 PM, but our staff has altered that schedule to only Fridays from 10:00 Am-12:00 Pm due to attendance and staffing.

Diamond Crest Update:

An official parking lot construction quote has been provided to BluSky Management on July 20, 2023. After the quote was received, the City was able to start the appraisal of the value of the land the BluSky Management is looking to donate in lieu of some tax credits. As of 8/14/2023 the appraisal was completed and now the City's Development department is reviewing the document to determine the details of the tax credit. Once completed and approved, BluSky Management will move forward with the construction of the parking lot.

Main Street Trail Water Fountains:

Over the past two years, Parks Maintenance staff have been dealing with reports of concerns with the water fountains along the Main Street Trail not turning off. Our department has been working with Lexington Plumbing to help solve the issue. Earlier this summer it was told to us that 6 valves between the two fountains broke, costing a total of \$9,000 for the parts plus labor. Over the past couple of months, we have been looking into alternative options and plan to purchase new water fountains that will be more reliable and recommended by Lexington.

Playground Resurfacing:

Next Generation Recreation is planning to schedule Smith's Fork resurfacing the last week of August and then will plan Heritage Park immediately after. The plan is to be wrapped up by September 15.

OK Railroad (previously Diamond Crest Trail) Grant Update:

Last week staff were notified that we made it to the second round of interviews for the RTP Grant with DNR. On Friday, August 18 staff met with DNR and answered questions to help be one of 3-5 projects funded for FY24. If this project gets funded, we will find out in October of this year.

Relocation of Humphrey and Nancy Smith Park

The Mayor and our Department have been working with the Smithville Historical Society again and have agreed to relocate the location of Humprey and Nancy Smith Park to the location of the River Walk Trail once completed. The location of the Mill will be along the trail and the current location of the park will not have much development. A vote will be needed.





Emerald Ridge Park Discussion and Timeline:

Back in July, we found out that we did not receive the Land and Water Conservation Fund Grant. This grant was submitted at the end of the year 2022 to help match the City funds for the construction of Emerald Park Amenities. Over the past couple of months, staff have been working with the Finance Department to rework the Parks and Stormwater Sales Tax projects to increase the budget for Emerald Ridge Park. As of Right now, we have \$450,000 in FY24 for Emerald Ridge Park.

The budget is set to be approved next month. Staff would like to introduce a couple of options to this committee. Option 1 is to put out a Request for Proposals (RFP). This was the process for Heritage Park Playground. This committee put together all features and needs wanted of the playground and multiple companies respond, they present, gather public comment, and we make a recommendation to the Board of Alderman. Option 2 is completing the process through a cooperative agreement (No RFP). We work with the companies directly and choose one and complete the purchase through a cooperative agreement. This is what we did for Diamond Crest Park. We would still need to get public comment and make a recommendation to the Board of Alderman.

The goal is to complete this process by December for construction to hopefully be completed by Summer 2024.
